**SECOND AMENDED SUMMARY OF SCHEDULES, AMENDED SCHEDULE B,  
AMENDED SCHEDULE F AND AMENDED SCHEDULE G**

Forward Foods LLC (the “Debtor”), debtor and debtor in possession, by and through its counsel, hereby files the attached Second Amended Summary of Schedules (the “Amended Summary of Schedules”), Amended Schedule B (the “Amended Schedule B”), Amended Schedule F (the “Amended Schedule F”) and Amended Schedule G (the “Amended Schedule G”). On February 17, 2009 (the “Petition Date”), the Debtor filed its Schedules (the “Original Schedules”). On April 3, 2009, the Debtor amended its Original Schedules by filing an Amended Summary of Schedules and an Amended Schedule F (the “First Amended Schedules”). The attached Second Amended Summary of Schedules, Amended Schedule B, Amended Schedule F and Amended Schedule G amend and replace the Original Schedules and the First Amended Schedules. Following is a brief description of the scheduled creditors affected by these amendments:

**I. Amendments to Schedule B**

Prior to the Petition Date, the Debtor, GE Capital (“GE”) and CitiCapital Material Handling Finance (“CitiCapital”) were parties to a prepetition lease whereby the Debtor was to make monthly installment payments towards the purchase of a forklift. The Debtor erroneously listed the forklift as property of GE and CitiCapital in its Original Schedules, rather than as an

asset of the Debtor. Accordingly, the Debtor submits Amended Schedule B to include the forklift as an asset of the Debtor.

## **II. Amendments to Schedule F**

### **A. Creditors with Increases in Their Scheduled Claims**

Subsequent to the Petition Date and the filing of the First Amended Schedules, the Debtor received numerous invoices for goods sold or services rendered which were incurred prior to the Petition Date and not reflected on the Original Schedules or the First Amended Schedules previously filed with the Court. Accordingly, the attached Amended Schedule F reflects increases in the nonpriority general unsecured claims of the following creditors:

### **B. Creditors with Decreases in Their Scheduled Claims**

Subsequent to the filing of the First Amended Schedules, the Debtor has received a number of invoices from creditors reflecting corrections to prepetition invoices. Some of these corrections are the result of pro-rated charges creditors had included in prepetition invoices for either actual or potential postpetition services. After reviewing these invoices, the Debtor has

determined that a number of general unsecured prepetition amounts listed on the Original Schedules included these pro-rated postpetition charges. Additionally, a further review of the Debtor's records reflects inadvertent errors in the posting of certain invoices, thereby reducing scheduled amounts. Accordingly, the attached Amended Schedule F reflects decreases in the nonpriority general unsecured claims of the following creditors:

**C. Creditors not Previously Scheduled**

Subsequent to the filing of the First Amended Schedules, the Debtor has become aware of potential prepetition claims not previously scheduled. Accordingly, the attached Amended Schedule F reflects the following disputed nonpriority general unsecured claims:

**D. RSM McGladrey, Inc.**

RSM McGladrey, Inc. ("RSM") was previously scheduled as a nonpriority general unsecured claim in the amount of \$47,440.00. RSM has agreed to waive its prepetition claim against the Debtor in order represent the Debtor as its accountant in this chapter 11 proceeding. Accordingly, the attached Amended Schedule F reflects RSM's claim being reduced to \$0.00.

**E. Silicon Counsel LLP**

Silicon Counsel LLP ("Silicon") was previously scheduled as a nonpriority general unsecured claim in the amount of \$1,365.00. Silicon has agreed to waive its prepetition claim against the Debtor in order represent the Debtor as an ordinary course professional in this chapter 11 proceeding. Accordingly, the attached Amended Schedule F reflects Silicon's claim being reduced to \$0.00.

**F. GE and CitiCapital**

GE and CitiCapital were previously scheduled as having nonpriority general unsecured claims in the amounts of \$2,263.74 and \$9,552.90, respectively. The claims of GE and CitiCapital were the result of a prepetition lease between the Debtor, GE and CitiCapital, however, CitiCapital's interest was previously transferred to GE. As a result, CitiCapital does not have a claim against the Debtor and GE's claim against the Debtor should include the claim

previously scheduled under CitiCapital. Accordingly, on the attached Amended Schedule F, GE is scheduled as a nonpriority general unsecured claim in the aggregate amount of \$11,816.64 and CitiCapital is scheduled in the amount of \$0.00.

**G. Protein Bar Technologies, LLC**

Protein Bar Technologies, LLC (“Protein”) is the plaintiff in prepetition litigation against the Debtor, which litigation was listed on the Debtor’s Statement of Financial Affairs, but erroneously omitted from the schedules. Thus, the Debtor’s Amended Schedule F lists Protein as having an unliquidated, disputed, nonpriority general unsecured claim in the amount of \$0.00.

**H. Hilmar Ingredients/Proliant Inc.**

The Debtor scheduled the \$42,791.99 claim of Hilmar Ingredients/Proliant Inc. (the “Hilmar Claim”) as a nonpriority general unsecured claim, however, the Debtor failed to mark the Hilmar Claim as liquidated. Amended Schedule F correctly identifies the Hilmar Claim as a liquidated claim.

**I. Stephanie Jones Public Relations, Inc.**

The Debtor’s records indicate that Stephanie Jones Public Relations, Inc. has a nonpriority general unsecured claim in the amount of \$5,864.71, however, the Debtor erroneously scheduled this claim twice. Accordingly, the attached Amended Schedule F reflects the removal of this duplicate claim.

**III. Amendments to Schedule G**

The Debtor is filing Amended Schedule G to include a rental service agreement with Cintas Corporation No. 3 and an equipment lease with Insight Global Finance. Additionally, as previously described herein, the Debtor, GE and CitiCapital were parties to a lease relative to the purchase of a forklift. The Debtor’s Original Schedules erroneously listed the forklift as a

personal property lease of both GE and CitiCapital. Thus, the attached Amended Schedule G reflects the removal of the GE and CitiCapital forklift lease, which property has been included as an asset of the Debtor in Amended Schedule B, as previously described herein.
